
1 Locations at risk of flooding. A Flood warnings

Area number	Location at risk	Trigger level	Actions
Area 1	Mill lane, Grampound bridge on the A390, Grampound with Creed School, Hall and recreation ground.	River Fal reaches the bottom of the bridge.	Call the Environment Agency's Floodline (0845 988 1188) for more information using the quickdial number 160003.
Area 2	Fore Street	Overflowing drains on Fore Street threatening to flood buildings and especially where heavy rain is expected. Old springs / water sources within houses during periods of prolonged rain.	Call the Environment Agency's Floodline (0845 988 1188) for more information using the quickdial number 160003.
Area 3	Old Hill	Overflowing drains and water from fields on Barteliver Hill threatening to flood buildings and especially where heavy rain is expected. Pooling of water near A390	Call the Environment Agency's Floodline (0845 988 1188) for more information using the quickdial number 160003.

Area number	Location at risk	Source of flooding	Direction of flooding
Area 1	Mill lane, Grampound bridge on the A390, Grampound with Creed School, Hall and recreation ground.	River Fal and tributaries	Outwards from the river banks.
Area 2	Fore Street	Rain water from road and fields.	Down the hill and into properties on the outside of bends and those below the level of the road. Particular properties with previous experience of water flooding.
Area 3	Old Hill	Rain water from road and fields.	Down the hill and into properties on the outside of bends and those below the level of the road.

In Area 1 the direction of flooding is outwards from the river banks.

In Areas 2 and 3 the direction of flooding is downhill especially on the outsides of bends in the roads. In this location "springs" have also appeared within certain buildings.

Area 3	Old Hill	Flood warning	Block the flow to properties on the outside of bends and below road level.	Sandbags and polythene sheeting.	2 hours

2 Actions to be taken during a flood. B Local volunteers / flood wardens

List of local volunteers / flood wardens that could be contacted in an incident. They may be required to lift heavy sandbags so should be reasonably active or fit. Consider using other volunteers as communicators, administrators or minders of vulnerable people during an incident. These volunteers could be registered on the Environment Agency's Floodline Warnings Direct Service so they receive the flood warning. **Volunteers must not put their own life at risk.**
