	<p><u>Chairman's Welcome / Public Forum</u> – the Chairman opened the meeting and welcomed those present.</p> <p>Mr and Mrs Marcks and their architect Mr Charles Green spoke regarding planning application PA19/04882 (Minute 102a[i]/2019). Mr Green explained the garden is long and rises steeply. The building will be cut into the ground. Parking space has been allowed in the design and it is anticipated vehicles will reverse into the parking area. It is a small dwelling for the applicants' use and would be designed to ease living conditions for the existing owners, who have mobility problems. Mr Green said he thought the design did not impact on the neighbouring listed building (Trengeffe). High quality materials will be used throughout, including traditional stone. Mrs Marcks said it was likely Trengeffe itself would then be sold.</p> <p>Cllr. Jones said properties opposite already have difficulties reversing out of their homes and their homes would face the stone wall of the proposed property. Mr Marcks said the rooms facing the new property are not main living rooms. Mr Green said improvements would be made to the road because some detritus (mud and vegetation) would be removed.</p> <p>Mr and Mrs Welford of Gramercy spoke against the planning application PA19/04882 (Minute 102a[i]/2019). They had provided their objections in writing which had been circulated to all Members. Their concerns included potential harm to the setting of the Grade II Listed Building (Trengeffe); harm to the approach to the Grampound Conservation Area, insufficient visibility splays, the design of the proposed new property and the loss of an 18M length of existing hedging. Mr Welford said the road was used as a 'rat run' to Truro.</p> <p>The Public Forum then closed and Minute 102a[i]/2019 was taken at this point.</p> <p>Mrs Roberson spoke regarding the application for Primrose Cottage (Minute 102a[ii]/2019). She gave a presentation explaining the proposed improvements. There are problems with damp that this application would remedy. The proposal includes the removal of the existing cement render. The cottage is not listed but is within the conservation area. The intention is to restore with sympathetic, high-end UPVC doors and windows.</p> <p>Cllr. Turner said another application in the area had been refused planning permission because of access issues. Mrs Roberson did not believe this would be an issue in this instance.</p> <p>Cllr. James queried how the chimneys would be dealt with and it was explained these would be retained and refurbished.</p> <p>The meeting then closed and Minute 102a[ii]/2019 was taken at this point.</p> <p>Members met with Mrs Liz Fisher regarding The Limes (Minute 104b/2019 refers). She had provided a written report following the site meeting with PC representatives (previously circulated via email).</p> <p>The Public Forum then closed and Minute 104b/2019 was taken at this point.</p>

Turner said the Planning Committee had made a site visit and felt it was a carefully thought out proposal, but there were concerns about highway issues and they wished to ensure the Eucalyptus tree was protected. The Meeting then closed and the Public Forum re-opened ii. <i>PA19/04505, Primrose Cottage, Fore Street, Grampound</i> – proposed rear 2 storey extension. Works to include replacement windows to the street elevation and the removal of existing render to face stonework. It was RESOLVED to support the application. Cllrs.
