Members SUPPORTED the application.</p> <p>b. <i>Planning Applications Approved by CC</i> –</p> <p>i. <u>PA20/00355/PREAPP, The Tannery Old, Tannery Lane, Grampound</u>– 5 Day Notice to remove dead wood from avenue of mature Sessile oaks (G1) over a pathway, to residential properties, for safety reasons and to reduce branch fall onto managed area.
