PL9/2020	<p><u>Members' Interests</u> –</p> <ul style="list-style-type: none">a. <i>Pecuniary/Registerable Declarations of Interests</i> – Members must declare an interest, which has been declared on their Register of Financial Interests form, relevant to the agenda.b. <i>Non-Pecuniary/Disclosable Interests</i> – Members must declare non-pecuniary interests at the start of the meeting or whenever the interest becomes apparent.c. <i>Declaration of Gifts</i> – Members are reminded they must declare any gift or hospitality with a value in excess of fifty pounds.	
PL10/2020	<p><u>Planning Applications</u> – including any applications received after the agenda had been published.</p> <ul style="list-style-type: none">a. <i>PA19/09765, Tredinnick Quarry, Grampound</i> - Proposal: Existing permission title - An aggregates recycling facility within the existing quarry void; the infilling of void with quarry wastes and other imported inert materials to provide site restoration; proposed quarry extension, and new access road and ancillary works - Planning Ref CC/CK/03/00354/WAS [CK41(5)] dated 22.02.2005. Permission expires 31.03.2020. For clarity, the current application is made under Section 73A seeking for variation/amendment/deletion (as appropriate) in respect of Condition Nos. 1-14, 19, 20, 22, 26, 28, 29, 33, 34, 35, 36 as explained in the Supporting Statement and document titled Proposed Amendments to Planning Conditions. For example Condition No. 2 specifies the current end date of 31.03.2020 and it is proposed to extend this to 31.03.2030 etc. Refer to the documents for full details of the other proposed changes. Mr Tim Warne, case officer had granted an extension to 12th May 2020. <p>NOTE – the applicant's Agent has revised the application and therefore this letter is effectively a re-consultation / notification on the application as it is now proposed.
