	a. <i>PA19/09765, Tredinnick Quarry, Grampound</i> - Proposal: Existing permission title - An aggregates recycling facility within the existing quarry void; the infilling of void with quarry wastes and other imported inert materials to provide site restoration; proposed quarry extension, and new access road and ancillary works - Planning Ref CC/CK/03/00354/WAS [CK41(5)] dated 22.02.2005. Permission expires 31.03.2020. For clarity, the current application is made under Section 73A seeking for variation/amendment/deletion (as appropriate) in respect of Condition Nos. 1-14, 19, 20, 22, 26, 28, 29, 33, 34, 35, 36 as explained in the Supporting Statement and document titled Proposed Amendments to Planning Conditions. For example Condition No. 2 specifies the current end date of 31.03.2020 and it is proposed to extend this to 31.03.2030 etc. Refer to the documents for full details of the other proposed changes. Mr Tim Warne, case officer had granted an extension to 12 <sup>th</sup> May 2020.
