Permission expires 31.03.2020. For clarity, the current application is made under Section 73A seeking for variation/amendment/deletion (as appropriate) in respect of Condition Nos. 1-14, 19, 20, 22, 26, 28, 29, 33, 34, 35, 36 as explained in the Supporting Statement and document titled Proposed Amendments to Planning Conditions.
